## Beyond Zoning: Acknowledge the Larger Regulatory Pot When Tackling the Housing Crisis

Developing housing involves more than zoning. We must address the larger regulatory pot, including subdivision regulations, building/fire codes, utility providers' templates, hard development costs, those developing, and those approving the developments. Let's have an honest conversation on the multitude of ingredients, looking at this through a broad lens that includes public sector, private sector, elected/appointed, and the general public.

#### **Anderson Center Station 2.0**

The redevelopment of Anderson Township's Beechmont Mall in the early 2000s triggered an effort to secure a new home for over 150 vehicles a day that utilized the mostly vacant site as an unofficial METRO park and ride. This process let to the development of the Anderson Center Station development in 2005, a suburban transit hub consistent with the "Metro Moves" plan, that not only complimented the nearby retail, office, park and government uses, but also was home to hundreds of public and private events for the next 15 years. However, as METRO ridership waned in 2015, Township leaders worked to facilitate a redevelopment of this key site, nestled in the heart of the Township. The new Vantage at Anderson Towne Center community will open in early 2025, fulfilling a number of community goals and serving as the next catalyst to ensure the economic vitality of "Downtown Anderson".

# About David J. Allor

David Joseph Allor was a professor of urban planning and head of the School of Planning at the University of Cincinnati. Raised in Mount Clemens, Michigan, he began teaching at UC in 1976 and rose to the position of Director of the School of Planning in 1989. He was President and Trustee of the Ohio Planning Conference (now APA-Ohio), helped establish the Ohio Planning Foundation, and wrote the Planning Commissioners Guide. His numerous awards and honors include Fellow of the American Institute of Certified Planners and the American Planning Association Distinguished Service Award. He was also a Senior Fulbright research scholar.

We at the APA Cincinnati Section named our annual Planning and Zoning Workshop in memory of his advocacy for educating citizen planners and the general public about planning, as well as for the countless hours he spent helping to train local planning commissions, often in jurisdictions that could not afford to hire a professional planner. He was a trusted mentor to many of his students as well as other planners in Cincinnati and throughout the region. Professor Allor championed the practice of planning up to his death at the age of 56 in April, 2000.
